**Recruitment of Probationary Officers in JMG Scale I - 2014-15: First Allotment**

We refer to the **(IBPS CWE PO/MT III)** common recruitment process for selection of POs/MTs in Public Sector Banks conducted by Institute of Banking Personnel Selection (IBPS), Mumbai and subsequent allotment of candidates made by IBPS to the Banks.

In this connection, we are glad to announce the list of candidates who have been provisionally shortlisted for the post of Probationary Officers in JMGS – I, based on the candidate's performance in the written examination, interview and their registered order of preference. The provisional list is prepared based on the allotment made by IBPS, Mumbai and further scrutiny at our end of the photo-copies of documents submitted by the candidates at the time of Interview.

Please note that this list is purely provisional, subject to the candidates being found medically fit and submitting acceptable documentary evidence (original) in respect of all eligibility criteria such as Age, Educational qualification, Category, Caste/ PWD Certificate as per Government of India format, etc., in the prescribed format at the time of joining the Bank, failing which the candidature will stand forfeited and the candidates will not be allowed to join the Bank. In case of candidates whose roll number is not appearing in the above mentioned lists, a separate email will be sent individually along with the reasons.

Decision of the Bank in respect of all matters pertaining to this recruitment would be final and binding on all candidates.
